We provide financial and technical resources and educational materials to local chapters to conduct outreach and education on workers' rights issues and to engage in workplace justice and community campaigns focused on expanding access to health care coverage, protecting our public safety net programs improving public education statewide, advocating for increased access to childcare services for low-wage families, and many more.

In addition to offering financial and technical support to our network of coalitions, we also provide leadership development and training opportunities for staff and leaders of our network and facilitate cross-train opportunities across the network.
