This is accomplished by providing financial, technical, and educational resources to more than 45 local Jobs with Justice Chapters. This support enables the Chapters to conduct outreach and education on workers' rights issues, and to engage in workplace justice and community campaigns focused on issues such as access to health care, labor law reform, global justice, immigration reform, and a people's economic recovery plan. The support we provided enabled the coalitions to work on 111 workplace justice campaigns affecting more than 135,000 workers. Key national projects in fulfilling our mission included: (1) the Student Labor Action Project develops student leaders and engages
